

## Center Rates 2024

**Fee/Payment:** Chanelle's Childcare strives to keep operation costs low. **Fees are non-negotiable and we DO NOT offer a family/multi-child discount.** 

Full- Time Childcare Fees: Full Time is 9 hours per day 5 days per week.

Chanelle's Childcare occasionally offers part time childcare. The fees for these services are increased as your child will be taking up a full time slot and only attending part time. Part time is defined as less than 4 hours per day OR less than 5 days per week. Drop in care/ Part time care/ Substitute care is a higher rate due to ratio and staffing guidelines.

Part- Time Childcare Fees: Part Time is less than 4 hours per day OR less than 5 days per week.

- **APPLICATION FEE:** There is a **\$25 Application Fee** to cover the cost of the tour and application process.
- ENROLLMENT FEE: There is a \$200 Enrollment Fee to cover the cost of equipment, curriculum, and supplies.
- WEEKLY PAYMENT: Your childcare fees are due on Thursday by 5 PM the week before services. If you do not remit payment at this time, a **\$30 Late Fee** will be charged. NO EXCEPTIONS.
- **CAFCP**: The Child and Adult Food Program provides reimbursement for meals and snacks at the center. Completion of all forms and income declaration are a requirement. You will need to provide written documentation from a doctor if milk or food substitutions are necessary.
- YOUR PICK-UP and DROP-OFF times will be discussed at your application submission. A late fee of \$5.00 will be assessed per every 5 minutes you are late to pick up your child. We understand that emergencies arise; these should be irregular and rare. If you will not be picking up your child on time you will need to call Chanelle and let her know who/when you will be picking up your child. If we do not here from you and no one arrives to pick up your child by 6 pm, we will call DCFS and Bloomington Police Department as is policy. Please refer to my Late Pick- Up/ Early Arrival sheet.
- CCAP/ CCRN/ DCFS although Chanelle's Childcare does accept children receiving subsidy payments, you are still responsible for the remaining charges. Chanelle's Childcare rates do not change for subsidy/ non subsidy children. Subsidy reimbursement is significantly lower than Chanelle's Childcare daily rates. Depending on your subsidy approval or income reported to the outside agency, your payment obligations may fluctuate. You are responsible for the difference in charges and the copay amount.

As a convenience to parents we provide a rate comparison sheet for center rates and CCAP reimbursement rates. This is a helpful guide to your weekly payment amount but may fluctuate due to subsidy reimbursement amounts and certificate approvals.

• SUMMER ACTIVITY FEE: There is a summer activity fee in the amount of \$75.00 due May 31 to cover activities for the summer. Parents are responsible to send a swimming suit, cover up, swim diapers, sunscreen, and water bottle in a bag for each child. Each item should be labeled.
